

**REQUEST FOR BIDS**  
**Surplus Property Sale – Seized Vessels**  
**Bid Due Date: Friday, July 10, 2020 by 1:15 P.M.**

Salmon Harbor is receiving bids for the sale of the following seized vessels:

Vessel #1:

Description: 36'10" 1967 Islander, OSMB registration OR401ACA  
Minimum Bid: \$200.00

Vessel #2:

Description: 27' 1982 Bayliner, OSMB registration OR862TS  
Minimum Bid: \$150.00

Vessel #3:

Description: 47'7' 1950 wood vessel, USCG Doc No. 260044  
Minimum Bid: \$300.00

Sale Conditions: Prospective Bidders are encouraged to review the proposed Bill of Sale for each vessel for full details of each sale. The Successful Bidder will be expected to execute the proposed Bill of Sale. The following is a non-exhaustive list of conditions contained within the proposed Bill of Sale:

- Each vessel is sold "As Is – Where Is," without any recourse against the seller
- All sales are final. There will be no refunds or adjustments.
- No warranty or guarantee is made as to the condition of each vessel.

**Bid Due Date: Bids are due no later than Friday, July 10, 2020 by 1:15 p.m.**

Bid Requirements: Bidders must use the bid form provided by Salmon Harbor, which requires Bidder to describe the vessel removal plan. Bid amount must be no less than minimum bid specified for each vessel.

Bid Submission: The bid form shall be enclosed in a sealed envelope marked on the outside "Sealed Bid— Seized Vessel Sale." Bids may be mailed to Salmon Harbor Marina, PO Box 1007, Winchester Bay, OR 97467, or hand-delivered to the Marina Office (located at 100 Ork Rock Road, Winchester Bay, OR 97467) during the hours of Monday to Friday 8:00 a.m. to 12:00 p.m. and 1:00 p.m. to 4:30 p.m.

Bid Opening: Bids will be opened July 10, 2020 at 1:30 p.m. at the Marina Office (located at 100 Ork Rock Road, Winchester Bay, OR 97467). Salmon Harbor intends to award the sale to highest Bidder for each vessel. The Successful Bidder will be notified by phone.

Execution of Bill of Sale: Full payment, in the form of cash or cashier's check, is due within 96 hours of notification of bid acceptance. If the Successful Bidder fails to execute the Bill of Sale, including tendering of full payment, within 96 hours of notification of bid acceptance, Salmon Harbor may revoke its bid acceptance with that Bidder and then award the sale to the next highest Bidder. Salmon Harbor may continue in this manner through successive Bidders until a sale is executed, or Salmon Harbor terminates the sale.

Salmon Harbor reserves the right to reject any or all Bids or withdraw any vessel from the sale.
